This is with reference to the proposal submitted by Methodist College of Engineering and Technology, King Koti Road, Abids, Hyderabad, Telangana-500 001 affiliated to Osmania University, Hyderabad under the UGC Scheme for Autonomous Colleges.

As per the decision of the Standing Committee constituted by University Grants Commission, in its meeting held on 01.09.2021, the Competent Authority has decided to grant autonomous status to **Methodist College of Engineering and Technology, King Koti Road, Abids, Hyderabad, Telangana-500 001** affiliated to **Osmania University, Hyderabad** for a period of Ten (10) years from the session 2021-2022 to 2030-2031 as per provisions of Clause 3.13 and Clause 6.4 (i) of UGC Regulations dated 12.02.2018.

The college shall also apply in the prescribed format to University Grants Commission for extension of autonomous status six months prior to the expiry of the autonomous cycle.
