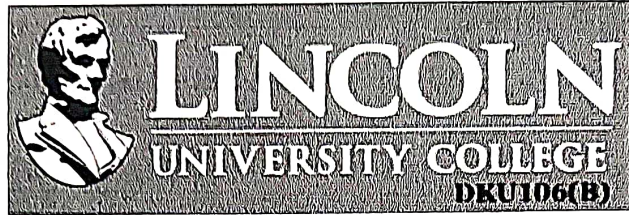



The goal of both the PARTIES would be to explore and establish a basis for their further cooperation in the areas of mutual interest. Both parties contemplate to attain academic horizon through mutual cooperation and exchange of support as follows.

General Scope:

Ph.D. Research

- Joint Ph.D. Research.
- Joint Research Proposals and Publications in fields of mutual interest.
- Extending Research guidance to Ph.D. aspirants from MCET.
- Assistance in pursuing Post-Doctoral Fellowship Programs.

Academic Programs

- Formulate Dual Degree Programs.
- Twinning Programs for UG & PG courses.
- Contemplate Academic Immersion Programs.
- Development of Joint Academic Programs.
- Support in Course Curriculum Design.

Exchange Programs

- Faculty Exchange for Teaching and Research Assignments.
- Student Exchange for appropriate level of Study and Research.

Events

- Organizing joint Symposia, Trainings, Workshops, Conferences, etc.

Additional terms of mutual agreement:

- Duration of programs introduced is likely to synchronize with MCET (Autonomous) or Osmania University programs.
- Concession in Fee Structure for MCET Faculty.

Specific activities and programs implemented under authority of this MoU shall be subject to availability of funds and the approval of each party's authorized representatives.

Separate Agreements:

Prior to initiating any specific activity or program, the parties will negotiate and enter into definite agreement, signed by each party's authorized signatory, describing the terms of the arrangement, including but not limited to financial commitments, academic freedom commitments, immigration and compliance obligation and details of the exchange or collaborative relationship.

Duration of MOU:



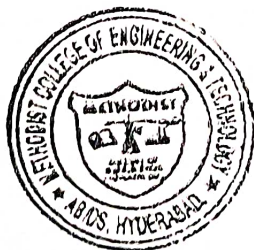
Additional Terms:
